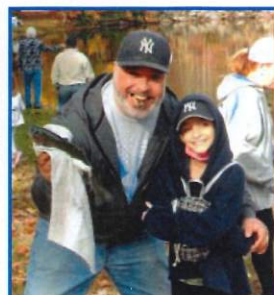

3D ARCHERY COURSE

The 3D course has been shut down and all the targets have been retired. The trails are available for hiking, Reminder – hunting season starts October 1st. If you take a walk, check the hunter sign in sheet first (to see if anyone is hunting & sign the book indicating that you are out there) and wear your hunter orange. BE SAFE!

ARCHERY RANGE

The range is looking good, there are yard markers for 20, 30, 40, 50 & 60 yards. **The archery range is open from 10am to 2pm during hunting season.** Crossbows may be used on the range (bag targets only). Use crossbow bolts and arrows with field points only. Styrofoam blocks that have been tied together may be used as a target for broadheads. The yellow chain is a caution to designate a possible live archery range.

TRI-COUNTY 3D SHOOT

Our tri-county archery season has ended. We are currently making plans for next season, if you have any suggestions please forward them to me or a committee member.

3. Boning Charge \$10.00 per piece. Shoulder and Hind. only
4. Products must be picked up on date given or be subject to a late charge of \$5.00
5. Not responsible for any product not picked up after 7 days of scheduled date.
6. 10lb minimum per product for processing
7. No drop off or pick up between the hours of 10:30am to 1:30pm

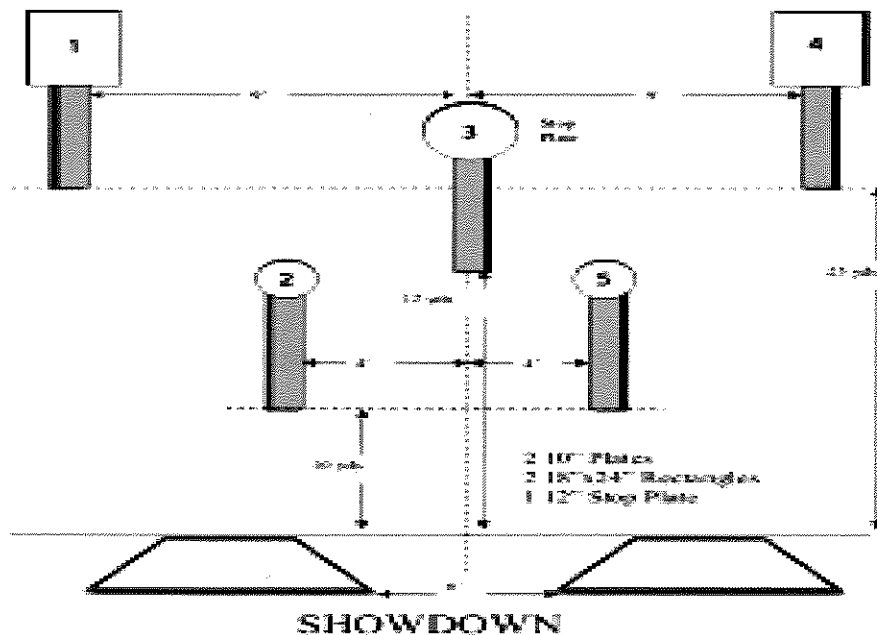
