Rifle/Pistol is open 10am to 9pm.

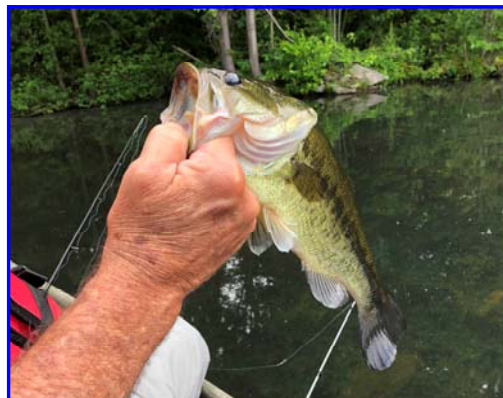
Archery 3D course has all targets out and ready to be used.
